Parent Agreement & Expectations

1. I am solely responsible for supervising my child(ren) during any and all online events as part of “Friendly Faces of Butano Creek.”
2. I understand camp staff are not in my home and cannot guarantee my child(ren) will stay in the online meeting or close to the device. I do not expect camp staff to supervise my child(ren).
3. I understand that participation in online events is entirely optional and at my or my child(ren)’s own risk.
4. If my child(ren) is under 13 years of age, I will maintain and supervise any online accounts they may need to access private online content.
5. I will notify camp staff privately of issues relating to the health and safety of my camper(s).
6. I will provide any electronic equipment needed for online participation, such as a computer, tablet, phone, internet access, headset or earphones and microphone, and required and up-to-date software. I understand damage to this equipment is the responsibility of the owner. I understand a desktop or laptop is optimal to access all features of the online environment.
7. For all live online events, I will ensure that my child and other members of the household are appropriately dressed and that the computer and camera that they are using does not show inappropriate things in our home. If possible, we will have their back against (or camera facing) a blank or non-descript wall, a wall with their camp drawings, use a nature zoom background, or blur the background. If staff notice something on my child(ren)’s video that is deemed not appropriate, they will turn off my child(ren)’s video until the issue is resolved.
8. I am aware that Camp Butano Creek will be recording all live online sessions for the safety and security of both campers and staff. All recordings will be stored locally and offline, not in the cloud. At the end of the summer, all recordings will be surrendered to Girl Scouts of Northern California for their records.
9. If possible, I will send camp staff photos of my child participating in online events, to be used in the end-of-week slideshow.
10. I have read over the Camper Agreement and the Girl Scout Internet Safety Pledge with my camper(s). I believe my camper(s) understands required behavior while participating in “Friendly Faces of Butano Creek.”

As staff of Camp Butano Creek, for the Friendly Faces of Butano Creek online program, our staff will:

- notify you if we feel something of concern occurs online.
- keep photos and videos created or shared through online interactions private. We will ask for permission before sharing photos and videos outside the private session environment.
- take the privacy and online safety of your child(ren) and family seriously.
- follow our schedule as closely as possible, or notify you if there has been a change.
- maintain appropriate girl-to-adult ratios, as identified in Girl Scouts of Northern California safety activity checkpoints.
